

ENERGY RECLAIMS

How is this possible?

Broker Fees	5p/kWh	£5,000
Supplier Profits	23p/kWh	£23,000
Reclaimable Amount	28p/kWh	£28,000

If you are happy to proceed, we will send it to our legal panel to kick start your claim- most claims are settled within 6 months

What documents do I need?

All we need for your claim are copies of your **energy contract(s)**, a few **bills** from each contract period, and **email exchanges** with your broker. Once we have this information we can calculate your possible claim value and then, when you are **happy to proceed**, we will pass your claim to our legal panel who are already processing many cases.

What is the basis for the claim?

Energy companies failed to disclose commissions on their contracts where brokers were used.

How much can you reclaim?

We reclaim not only the brokers commissions but also the suppliers profits which could be up to 80% of ALL energy costs.

How many years can you claim?

We can go back up to 23 years

How long will the process take?

Will I have to go to court?
